BY-LAW NUMBER 10-2020

Being a by-law to establish user fees

WHEREAS Section 391 of the Municipal Act, 2001 S.O. 2001, C.25, as amended provides authority for a Council of a Municipality to pass bylaws imposing fees or charges on any class of persons, for services or activities provided or done on behalf of them;

NOW THEREFORE the Council of The Corporation of the Township of Faraday enacts that the following charges shall be applied:

THAT the fees listed, where applicable be subject to any applicable provincial and federal taxes and;

THAT the following schedules shall form part of the bylaw: -

- Schedule "A" - Administration and Finance,
- Schedule "B" - Community Centre,
- Schedule "C" - Property, Planning and Zoning; and
- Schedule "D" - Landfill

THAT this by-law repeals any and all other fees that exist in other by-laws, pertaining to same, that predates the effective date of this by-law.

THAT the following fees shall be applied for each respective department or service area:
